Bosnia and Herzegovina is the Borrower, and Republic of Srpska, through a subsidiary agreement with the Borrower, has received financing from the UNDP/GCF toward the cost of the Scaling-up Investments in Low-Carbon Public Buildings in Bosnia and Herzegovina and intends to apply part of the proceeds for consulting services.

The reference list should contain information about the clients, assignment descriptions of relevant projects, value of the contracts and period of execution supported (2) demonstrated technical and managerial capabilities of the firm, including information on the qualifications of proposed key staff; all individual experts for the assignment (individual experts' bio data are not required for expression of interest) must have at least a university degree and 7 years of professional experience. The selected firm and individual experts would need to possess (at the time of contract signing) necessary professional licenses for the required services in accordance with the requirements of the Republic of Srpska legislative and regulatory framework.
